3. _____ **The vehicle has _____ of fuel right now**; all we ask is you bring it back with the same level of fuel. There is a station right across the street if you forget. If you do choose not to refill before returning a charge of \$3.00 per gallon will be added to your service ticket.
4. _____ Do you see any **dents, dings, scratches or other problems** with the vehicle? If so, please describe them on the lines below.

5. _____ We offer these rental cars at competitive rates and to continue to do so we must **keep track of the miles driven**. The purpose of these cars is to keep you on the road so you can go on with your day, even when your car is in the shop.

In consideration of Pettijohn Auto Center (hereinafter called the Lender) loaning or renting the above described motor vehicle, I hereby accept full responsibility for its operation and agree that I will not operate it contrary to the laws of any jurisdiction in which it is being operated; I also agree to indemnify and hold harmless said Lender for any claim or claims of personal injury or property damage to others or myself arising out of the use or operation of said vehicle. I further agree not to allow anyone else to drive said vehicle and to deliver it to the lender on, or before the date specified for its return in as good mechanical and physical condition as when it was loaned to me, or to pay the Lender immediately for any repairs necessary to restore said vehicle to the same conditions as when I received it. In the event of any accident involving said vehicle, I will within twelve hours of the accident, furnish Lender and, if required by law, the Missouri Motor Vehicle Safety Responsibility Unit, a full and complete report thereof, and will also hold Lender harmless and indemnified for any damage, cost or expense in connection therewith. I also agree that I will not authorize or incur expense of any nature whatsoever for the repair of said indemnified the Lender against all claims and demands, including parking tickets, arising or resulting from the use, storage and/or repairs of and to said vehicle during my custody of same. It is expressly understood by me that I have permission of the Lender to operate said vehicle only during the period stated in this document and if I operate said vehicle beyond the time specified for its return I do so without the permission of the Lender. If said vehicles is stolen from my custody, I will immediately notify said Lender of such theft, but shall not be otherwise liable for the return of said vehicle or with respect to its operation after such theft.

If any provision herein shall conflict with or have the effect of depriving any of the parties of the benefit of any insurance coverage applicable in the absence of such provision then such provision shall not be effective and is void, but the borrower shall remain subject to all other legal liabilities imposed by law.
